LICENSING ACT 2003
PREMISES LICENCE APPLICATION FOR PATTY & SAUCE, 7 DRAYTON
GREEN ROAD, EALING, W13 0NG (HANWELL BROADWAY WARD)

DECISION

The sub-committee carefully considered the application for a premises licence which had been made by Mr Imran Chaudry in relation to Patty & Sauce, 7 Drayton Green Road, Ealing, W13 0NG as set out in the agenda pack. At the hearing, verbal submissions were made in support of the application by Mr Chaudry, owner of the business. The sub-committee carefully considered the written and verbal representations in objection to the application from the council's Noise and Nuisance Team, from the Metropolitan Police Service and from the Walpole Resident's Association.

The sub-committee took into account Ealing Council's Statement of Licensing Policy and the Home Office Revised Guidance (December 2023) issued under S.182 of the Licensing Act 2003.

For the reasons outlined below, the licensing sub-committee's decision was to grant the application in part, to allow Late Night Refreshment (LNR) for the following hours only:

Sunday – Thursday

Late Night Refreshment (LNR) 23:00hours till 12 midnight

Friday - Saturday

Late Night Refreshment (LNR) 23:00hours till 01:00hours (1am)

REASONS FOR THE DECISION

The sub-committee noted the extensive written and verbal representations from the responsible authorities and residents' group objector on the lack of confidence in the applicant's understanding of the licensing objectives and the impact of his Late Night Refreshment application until 5am, specifically on the residents in the vicinity of the premises.

The sub-committee considered Mr Chaudry's written application which set out a detailed operating schedule which described how he intended to address the four licensing objectives. The committee also heard from Mr Chaudry on his vision for the premises, his understanding and acknowledgement of the concerns raised by the responsible authorities and objector around the crime and disorder and public nuisance objectives. Mr Chaudry demonstrated a clear awareness of the

surrounding area to his premises and the problems potentially associated with late night refreshments in the area and it was clear during Mr Chaudry's representations that he wanted to ensure that he complied fully with the licensing objectives and that he recognised that for him to do so correctly it would involve him working more closely with the responsible authorities and take on board the matters raised at the hearing by the police and licensing authorities and to ensure he was doing everything he could to uphold the licensing objectives.

The above hours for LNR were considered to be proportionate and appropriate, given the locale of the premises.

RIGHT OF APPEAL

The Applicant, licence holder or any person who made relevant representations may appeal against the sub-committee's decision. An appeal must be made to the Ealing Magistrates' Court within the period of 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision appealed against.
