

# **Ealing Council Statutory Forward Plan**

Published Version – 1 February 2024 to 31 May 2024

#### The Forward Plan

In line with the Local Government Act 2000, Council's are required to publish a monthly Forward Plan. Ealing's Forward Plan provides details of the key and non-key decisions to be taken by Cabinet or individual portfolio holders, or key decisions that officers intend to take, over the next four months.

The updated forward plan will be available twenty-eight clear days in advance of the date of the key or non-key decision. The Forward plan gives information about:

- Key and non-key decisions to be taken by Cabinet or individual portfolio holders, or key decisions that officers intend to take, over the next four months.
- When these decisions are likely to be taken.
- What consultation will be undertaken
- Background Documents
- Who you can make representations to and contact for further information.

#### **Definition of a Key Decision**

A key decision means an executive decision, which is likely:

- (a) To result in the council incurring expenditure which is, or the making savings which are, significant having regard to the council's budget for the service or function to which the decision relates, or
- (b) To be significant in terms of its effects on communities living or working in an area comprising two or more wards or electoral divisions in the area of the council

For the purpose of this definition savings or expenditure will not normally be considered to be significant if less than £500,000.

It is the Council's usual practice to require all reports intended for submission to the Cabinet and Portfolioholders to be included in the Forward Plan whether or not they are key decisions. The only exception to this rule is where the report author is able to demonstrate that a particular urgency exists.

#### Reports

Reports will be available on the Council's website a minimum of 5 working days before the relevant meeting.

#### **Decisions**

All decisions taken by Cabinet may be implemented unless called in by Councillors. The 5-day call in period begins once the minutes or decision sheet have been published.

Report Title	Acquisition programme to increase supply of housing for temporary accommodation
Details of Decision	To seek approval for drawdown of capital funding for a programme of acquisition of properties to increase temporary accommodation supply. The programme will cover individual property acquisition; bulk property acquisition; freehold and long leasehold arrangements as well as use of other acquisition approaches. This will increase the number of homes that the Council owns to be used as temporary accommodation enabling better management of the property and condition as well as reducing the cost of provision.
