The screening workshop, which forms part of the recruitment process, takes place in Council offices to act as part of the orientation to future working in the Council offices. This helps to manage expectations and allay concerns or 'myths' about the office working environment. The screening process forms part of the 'induction' process and supports candidates as part of their preparation for interview with their potential new manager in the work setting they would be working in. As part of the recruitment process, hiring managers are encouraged to bring final candidates into the work setting and give them tasks that they could be doing in their apprentice role. This can help the manager to see how the candidate interacts with the team and what quality their pieces of work are. It also helps candidates to experience what the workplace setting is like. To date, only one final candidate decided that they did not like the work setting (Perceval House). Apprentices with disabilities that require specialist equipment or training are linked in with Access To Work and their recommendations completed as necessary.
