Conditions must only be imposed where it is appropriate to promote one or more of the four the licensing objectives and should be derived from any relevant representations made in respect of the application. The conditions will be focused on matters, which are within the control of individual licensees. The primary focus will be on the direct impact of the activities taking place at the licensed premises on members of the public living, working or engaged in normal activities (including the right to sleep) in the area concerned.

5.4 Licensing Policy Core hours for licensable activities

The Policy outlines, at paragraphs 2.11 onwards, core hours for the provision of latenight refreshment and/or supply of alcohol. The Policy recognises that licensable activities carried on within the core hours set out below will generally not have a harmful impact on the licensing objectives. The core hours are:

The Council's Licensing policy states that applications outside the core hours will all be considered on their own merit. The Authority will take the following matters into consideration when making a decision. These are not a definitive list and other matters may be considered:

- Operating schedules demonstration of compliance with management standards to support each of the licensing objectives.
- Proximity to residential accommodation the likelihood of the operation to have an adverse impact on the peace and quiet of local residents.
- Potential noise and nuisance from people leaving and entering the premises.
 Ability to demonstrate that systems in place to ensure timely dispersal of customers away from residential areas.

6.0 Legal implications

A licensing authority must carry out its licensing functions under the Licensing Act 2003 (the Act) with a view to promoting the licensing objectives:

- · Prevention of crime and disorder:
- Public safety;
- · Prevention of public nuisance; and
- · Protection of children from harm.

The Committee must have regard to its Statement of Licensing Policy and the Guidance issued by the Secretary of State pursuant to Section 182 of the Act.

Where the licensing authority rejects an application for a premises licence (either in whole or in part) the applicant may appeal against the decision to a magistrate's court within 21 days of being notified of the decision.

A person who has made relevant representations may also appeal against a decision to grant a licence either on the basis that the licence ought not to have been granted or on the basis that different or additional conditions should have been imposed, again, within 21 days of being notified of the decision. 7.0 Human Rights In determining the application you should be aware of and take into account any implications that may arise from the Human Rights Act 1998. Under the Human Rights Act it is unlawful for a public authority such as the London Borough of Ealing to act in a manner which is incompatible with the European Convention on Human Rights. You are referred specifically to Article 6 (the right to a fair trial), Article 8 (the right to respect for private and family life) and Article 1 of the First Protocol (the protection of property). - 1. Strict implementation of challenge 25 policy
- 2. CCTV to be installed and 31 days recoding system
- 3. All staff to be trained in responsible alcohol retailing
- 4. Training manual will be available at the premises
- b) The prevention of crime and disorder
- 1. CCTV to be installed to the satisfaction of the Police. This will be judged in relation to the advice available in the Home Office Scientific Development Branch (HOSDB) document "CCTV Operational Requirement Manual 28/09" with special emphasis on the provision of "identification quality" images of people entering or leaving the premises through any doorway.
- 2. The system must provide general views of the interior of the premises and exterior areas where relevant.
- 3. The system must record and store images for 31 days and must record between 6 to 12 frames per second. It must be able instantly to download recorded images onto a readable format (CD or DVD) at the time of request. I.e. to prevent any need to seize the hard drive thus rendering the system inoperative.
- Staff working at the premises shall be trained in the use of the equipment and a log will be kept to verify this. At least one member of staff, so trained, shall be present at the premises at all times when it is open for licensable activities.
- 4. If the CCTV equipment is inoperative, or is otherwise not installed and working to the satisfaction of the Police and Licensing Authority, the premises must not be used for licensable activities unless with prior agreement from the Police.
- 5. Operation of the CCTV equipment to be checked at least every seven days by the management and a written log recording this must be kept and made available for inspection. If inoperative this is to be reported to the Police and the Licensing Authority without delay
- 6. CCTV images must be made available for playback in store to Police or Council Licensing Officers at any time the store is open
- 7. CCTV images along with a software player to enable viewing must be provided to the Police or Council Licensing Officers within 24 hours of request
- 8. Notices must be displayed at the entrance to the premises and in prominent positions throughout the premises advising that CCTV is in operation. For the purposes of these CCTV conditions "the Police" refers to the licensing partnership office of Ealing Police Station and the "Licensing Authority" refers to the Licensing Authority of the London Borough of Ealing
- 9. The CCTV system must record all entrances and exits to the premises at all times. It must also record the outside of the premises, capturing images of delivery persons and vehicles and where possible, the camera should be situated to capture vehicle registration numbers of any delivery vehicle.
- 10. There must be no stock or sale of high strength canned beer, lager or cider (above 6.0% ABV). All beer, lager or cider must be clearly price marked.
- 11. There must be no single cans of beer, lager, cider, ale or spirit mixtures sold at the premises.
- 12. No miniatures to be sold at the premises (5cl)
- 13. All staff employed at the premises will have UK right to work status checked, once passed that stage they shall be offered employment.
- 14. An management agreement has been made and signed by all parties involved, the agreement is a period of 5 years. A copy of agreement will be provided with the application, new business bank account has also been opened under HM Food and Wine ltd.

- 15. Invoices for all alcohol, tobacco and vape products to be made available immediately when requested by council officers or Police Officers.
- 16. Mr Gurjeet Singh Khurana shall not have any involvement in the Retail section of the premises (Please see plan) as that is under new managment of HM Food and Wine ltd for a period of 5 years, Mr Gurjeet Singh Khurana will work in the Post Office area as he is the post office manager and postmaster.
- 17. All staff to be trained every 3 months in relation to be licensing objectives and making sure they are promoted properly.
- 18. The Premises Licence Holder shall ensure that an "Incident report register" in which full details of all incidents are recorded. This shall be completed as soon as possible and in any case no later than the close of business on the day of the incident. The time and date when the report was completed, and by whom, is to form part of the entry. The register shall be kept on the premises at all times and shall be produced to an authorised officer of the Licensing Authority or the Police upon request
- 19. During any hours after 18:00 hrs a minimum of 2 staff must be on premises to prevent crime and disorder.
- c) Public safety
- 1. Installation of appropriate safety equipment
- 2. Fire exit signs displayed
- 3. To comply with all current, fire, health and safety laws
- 4. CCTV working at all times
- d) The prevention of public nuisance
- 1. Notice displayed asking customers to leave quietly from premises also customers will be told in person to leave quietly and not to disturb the local neighborhood
- 2. Strict policy in place to tell all staff not to serve alcohol to drunks at all
- 3. Appropriate signage will be displayed, in prominent position informing customers they are being recorded on CCTV
- e) The protection of children from harm
- 1. A challenge 25 policy will be in force, where any person looking under the age of 25 shall be asked to prove their age when attempting to purchase alcohol and signs to this effect will be displayed at the premises. Challenge 25 posters displayed where alcohol is sold.
- 2. The only acceptable ID will be those with photographic identification documents, including passport, photo-card, driving license or proof of age card bearing the PASS hologram.
- 3. An refusal book shall be kept at the premises and updated as and when required, and made available for inspection on request to an Licensing Officer, Police or other responsible authority.
- 4. The licensee will ensure that staff are trained regularly as appropriate in respect to the Licensing Act 2003 legislation, staff to be trained regularly in underage sales prevention.
- 5. A sign stating "No proof of age No sale" shall be displayed at the point of sale.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay







Representation

This application is for a new premises licence for HM Food & Wine, 16 King Street, Southall, UB2 4DA.

HM Food & Wine is situated on a busy high street and is located in a Special Policy Area within the London Borough of Ealing.

The Special Policy Area (SPA) was put in place in KING STREET, due to the area being largely affected by crime, anti-social behavior and nuisance, more so than other areas on the borough. The London Ambulance Service also has a high volume of alcohol related calls to this area.

With an SPA in place, the onus is put on the applicant to demonstrate that if the premises is granted a premises licence, that it will not be adding to the existing problems in the area.

The applicant is Mr Satpal Singh VADVA, who has one conviction in 2009 for selling alcohol to a person under 18.

The premises has previously had a premises licence, under the name of Mann Food & Wine which also has a post office. The previous licence holder and designated premises supervisor was Mr Gurjeet Singh Khurana. The licence was revoked by the licensing committee on 15/11/2023 when an application to review the premises was submitted by Trading Standards, after a number large number of unpaid duty products were seized, amounting to the value of £3850.

An appeal was submitted on 5th December 2023, allowing the premises to sell alcohol until the hearing appeal date at Uxbridge Magistrates Court on 7th April 2024. The appeal was withdrawn two days before the hearing on 5th April 2024.

On 15th March 2024, this new premises licence application was submitted.

In the application, the applicant Mr Satpal Singh VADVA has put in the operating schedule of the application 'Mr Gurjeet Singh Khurana shall not have any involvement in the Retail section of the premises (Please see plan) as that is under new managment of HM Food and Wine Itd for a period of 5 years, Mr Gurjeet Singh Khurana will work in the Post Office area as he is the post office manager and postmaster'.

Due diligence has been carried out by police and Companies House shows that HM Food & Wine Ltd was incorporated on 29th February 2024, with Satpal Singh VADVA as the director. Companies House also shows a company called GHS Properties Ltd and the active directors in this company are the previous premises licence holder Mr Gurjeet Singh Khurana and the applicant Satpal Singh VADVA. They have also both been directors together of another company called GHS Trading limited. Satpal Singh VADVA is still currently a director, Gurjeet Singh Khurana resigned in October 2022.

It is clear from the evidence above that the previous licence holder Gurjeet Singh Khurana and the applicant Satpal Singh VADVA are known to each. The Metropolitan Police believe that they are still in business together and are concerned that the licensing objectives will not be promoted.

Therefore the police object to this application and make our representations to the application, in its current form and object under three of the four licensing objectives.

We reserve the right to draw on any further evidence or information which may come to light.

Representation

This representation is made under two of the statutory licensing objectives - the Prevention of Crime & Disorder and the Prevention of Public Nuisance.

I currently work as a Licensing Compliance & Enforcement Officer within the Licensing Team in Regulatory Services of Ealing Council, a position I have held since September 2016.

The borough has over 1300 premises licence, 48% of which are off licences with the most being in the Southall area.

These premises were previously named Mann Food & Wine which is also a Post Office.

The premises have been licensed since 08 October 2010 and the licence was transferred to Mr Gurjeet Singh Khurana who is also the Designated Premises Supervisor on 14th July 2020

Following a licensing visit, accompanied by an officer from Trading Standards on 14th February 2023 an application was made to review the premises licence on 4 October 2023.

On that visit 198 x 20 packets (3960) cigarettes, 114 x 20 packets (2280) counterfeit cigarettes, 20 x 50g pouch (1kg) RYO tobacco, 1070 prescription and Viagra tablets, 12 x 250g packet (3kg) poppy seed, 120 small Nitrous Oxide canisters, 385 non-complaint vapes, and 472 packets (1.9kg) Indian tobacco were seized.

The unpaid duty on the products amounted to over £3850.00.

On 15/11/2023 following a sub-committee hearing the members made the decision to revoke the licence, a decision that was appealed on 5 December 2023 enabling the premises to trade for a further 5 months. The appeal was then withdrawn 2 days prior to the appeal hearing at Uxbridge Magistrates Court on the 5 April 2024, this new application was submitted on 15th March 2024.

This is an application for a new premises licence in the Special Policy area in Southall, that was adopted due to the data indicating rises in ASB and alcohol related crime & disorder.

Under that Policy that was adopted by the full Licensing committee in July 2020 there is a rebuttable presumption to refuse all new premises applications and

Para 2:12 states "that the policy is intended to be strictly applied, Exceptions must be genuinely exceptional".

One possible circumstance is "Substitute one premises for another, where the size and location of the second (new) premises and the hours sought are the similar to the previous Premises Licence granted at this site. Also, this will not be a substitution as the premises quite rightly lost its Premises Licence, a decision that were upheld following the withdrawal from the Appeal process.

Para 2:13 "Exceptions unlikely to be made on grounds of".

That the Premises will be well managed – It is unknown whether the applicant has previously held a Premises / Personal Licence and has ever been a Designated Premises Supervisor (DPS). This is unknown.

There are no dwellings nearby – These premises are situated in a highly residential area with more properties above the commercial units.

1.20 The effect of adopting a Special Policy is to create a rebuttable presumption that applications for the grant or variation of premises licences or club premises certificates which are likely to add to the existing cumulative impact will normally be refused or subject to certain limitations, following relevant representations, unless the applicant can demonstrate in the operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives. Applicants should give consideration to potential cumulative impact issues when setting out the steps they will take to promote the licensing objectives in their application.

The applicant in his operating schedule has submitted "standard conditions" and has considered high Strength beer to the point that beers above 6% abv will not be sold in single cans, but in my opinion, it demonstrates that a large part of his business will be alcohol and he will be able to sell multiple cans of up to 6% abv.

Especially as the ABV on the previous licence was 5.5%. The plan shows that alcohol will be the main products and will amount to 50 – 60% of the stock in the shop. He has stated that Gurjeet Singh Khurana involved in the previous premises, will not be involved in the new venture, and only allowed to work in the Post office as he is the Postmaster.

This is a condition offered by the "new buyer" however he will not be able to adhere to it as the named person is in fact the leaseholder who still be allowed in the premises, albeit behind the glass enclosed Post office counter, from which in the review hearing he stated that he had not seen staff bringing in illicit cigarettes and hiding around the shop including in the drawers of the photocopier which is situated 10 feet in front of the P.O Counter. The toilet is situated in the same storeroom where the alcohol is currently stored and where boxes of Hula hoops containing counterfeit cigarettes were located.

There is also nothing stopping the Sub-lease/Management agreement being transferred back to Mr Khurana if a new Licence was to be granted.

1.38 Studies have shown that the number of off- licences in an area is a factor in prevalence of street drinking. Local data shows that there are incidences of alcohol-related crime and ASB occurring in parks and open spaces in the borough in close proximity to off-licence premises.

In a 250 - metre radius of the shop there are currently seven (7) premises permitted for OFF sales.

This means that on most days and particularly after 5pm you can see groups of males drinking strong alcohol in the street, especially near to the temple and on street corners. This just makes the area intimidating especially for lone females and vulnerable people.

There has also been an increase in violent incidents involving drunk males.

The sole director of the company making this application is Satpal Singh Vadva who incorporated the company on 24 February 2024. A further check revealed that this is the fourth appointment as a director of a company and in fact he was a company director with Mr Gurpreet Singh Khurana for over 2 years of GHS Trading Ltd until Mr Khurana resigned in October 2022. Both companies trade in like products.

I visited the premises on Monday 8 April 2024 and after introducing myself stated the purpose of my visit was to check that no alcohol was on display, available for sale or on the premises as it did not have a current authorisation under the Licensing Act and that included checking the storeroom where less than 12 months previously illicit products were found hidden in boxes. When the staff were told they telephoned Mr Khurana.

He stated that he had already sold the business and had been advised that it was ok to store the alcohol in the store. When asked where the new owner was he stated he was on holiday.

Behind the post office counter there was a male and female that I had seen on the 2 occasions serving customers from the Post office counter. In the storeroom that was accessible and near the post office counter a vast stock of alcohol including high strength beer and miniatures was found, both items that the new owner states will not be stocked in his shop as per his offered conditions. These cans ranged from 5.9 – 8.5% abv. This is the same stock that Mr Khurana stated

that was purchased with the new lease. I took 4 Photographs of the beer and

Miniatures and now exhibit these as RD 1-4.

Further proof of the intent of the "new owner" and the clientele that they are

looking to attract.

There is nothing in the application in respect of the experience or previous

venues run or owned by the sole person applying for this new licence, however it

is known that he is a PLH in the Borough of Hounslow

Therefore, my recommendation is that the application is refused in full as I do not

believe that there are any conditions that would allay my concerns and would

only have a further negative impact on the area not due to just the number of

other off licences in the area but in particular premises that have been known to

be non-compliant.




EXHIBIT RD2 High strength beer above 6% abv (Karpackie 9% Skol 8.5%) HM Food Ltd




EXHIBIT RD/4 High strength cans Debowe 8% H M Food Ltd 08.04.2024
